

3. The affairs of the Trust shall be carried on and administered by a Board of Trustees having a membership not exceeding eleven persons and not less than five persons.
4. The Founders hereby nominate the following persons as Trustees to start with and they shall continue to be the permanent members of the Trust till death or resignation or incapacitation or by the effect of any legal intervention

THE OBJECTS OF THE TRUST SHALL BE:

- a) To establish, run, maintain, assist, finance in the setting up and maintenance of Primary, Secondary, Higher Secondary Schools, Colleges including Technical, Medical and other Educational Institutions for the need and relief of the students.
- b) To foster, impart, and encourage education and training in arts, science, handi-crafts and fine arts.
- c) To conduct meetings, seminars, debates, exhibitions on objects which are beneficial to the public at large.
- d) To encourage research and development in art, literature, culture and Science.
- e) To grant, pay or give scholarships, stipends, subsidies, prizes and other financial assistance or help in cash or kind to the poor and needy.
- f) To print and publish books, pamphlets, periodicals of the advancement of education and culture.
- g) To purchase, take on lease, exchange, hire or otherwise acquire any real or personal property and any rights or privileges necessary or convenient for the activities of the Trust and to construct, alter and maintain buildings required for such purposes as determined by the Trustees.
- h) To sell, improve, manage, develop, lease, mortgage and to deal with all or any part of the property of the Trust for its development as determined by the Trustees.



- i) To invest the surplus funds of the Trust in such Securities or otherwise in such manner as may from time to time decided by the Trustees.
- j) To collect funds for carrying on the above objects
- k) To make any alterations, ammendments and or additions to the above objects for the smooth and successful running of the Trust.
- 5) The Trustees shall utilise the assets for the Trust to carry on and fulfill the aforesaid objects in accordance with the majority decision of the Trustees. The founders hereby relinquishes for all time any claim to or interest on the amount of Rs. 1, 000/-, but they will be having the claim and right over one fifth portion of the said capital Investment just like the remaining members of the Trust.
- 6) Each member of the Trust shall have the right to advance or arrange loans of further amounts for the successful functioning of the Trust activities on terms and conditions formulated by the Board of Trustees from time to time.
7. The Trustees shall manage the fund of the Trust as economically and with circumspections as they may jointly decide at a meeting or by circulation resolved upon. Such decisions shall be taken by the Managing Trustee.
8. The Managing Trustee shall be at liberty to co-opt or nominate members to the board of Trustees as per the timely requirement for the sucessful running of the Trust.
9. If any vacancy arises in the Board of Trustees on account of death, incapacity, or resignation may co-opt any person by the Managing Trustee.
10. The Trustees shall formulate and regulate necessary rules for the efficient functioning of the Trust activities and for the implementation of the objects of the Trust.
11. The following members of the Trust shall hold their office as mentioned against their names for their life time. They shall act as per the timely decision of the Board of Trustees.

Any of the above Officers shall be free to resign from the post on personal reasons and the vacancy so occurred shall be filled in by concensus or election by majority from the board of Trustees. However irrespective of life time the office bearers can be removed by a 2/3 majority of the Board of Trustees in a meeting specially convened for the purpose.

12. The Bank account of the Trust shall be operated by the Managing Trustee.
13. The Board of Trustees shall have the power to accept donations from other with or without special condition attached there to, provided any such condition does not contravene the aim, objects and interest of the Trust.
14. The Managing Trustee shall be the manager of the Education Institution for purposes representing the Trust in such affairs. He shall take timely advice from the Board of Trustees.
15. The true and correct accounts of all receipts and disbursements relating to the Trust hereby constituted shall be kept by the Treasurer. An income and expenditure account for the whole financial year upto date shall be prepared by the 31st day of financial year by the Treasurer. An income and expenditure account for whole financial year upto date shall be prepared by the 31st March. The Accounts and balance sheet shall be audited by a chartered Accountant appointed by the Board of Trustees. As soon as the audit report is obtained a meeting of the Board of Trustees shall be held in which the accounts of the Trust and the report of the Auditor concerning the same shall be examined and adopted.




16. The quorum of the Trust Meeting shall be 1/ 2nd of the total membership of the Trustees.
17. As and when found necessary the clauses of the Trust Deed can be altered, amended, added or deleted by a 2/3 rd majority of the Board of Trustees without tampering the aim and main frame and membership clauses.
18. In the event of the Trust becoming defunct or extinct, the Trust assets and liabilities shall be disposed off as per the relevant statutory provisions.
